Payment in full is required when bookings are made after August 1, if space is available. The right is reserved to decline any person as a member of any tour at any time, in which event an equitable amount will be refunded. **Group size is capped at 26 paid participants; and spaces will be filled in the order in which reservations and deposits are received.** If we receive more reservations, we will keep a waiting list in the event of cancellations. If we receive less than 20 deposits by March 1, we may cancel the trip.

**The right is reserved to change any route or arrangements should conditions necessitate, to offer substitutes of equal value, or to cancel the operation of any scheduled excursion.** Individual transfers are not included in the land cost.

*Notification of cancellation must be made in writing, with the cancellation date being the postal service postmark date. At the time we receive your notification, the following charges apply: (charges are per person)*

Up to 120 days before departure	10% of tour price plus any related credit card fees
120 - 60 days before departure:	40% of tour price plus any credit card fees
60 - 0 days before departure	100% of tour price plus any credit card fees
