Payment in full is required when bookings are made after August 15, if space is available.

Group size is capped at 26; and spaces will be filled in the order in which reservations and deposits are received. If we receive more reservations, we will keep a waiting list in the event of cancellations. If we receive less than 20 deposits by March 15, we will cancel the trip.

CANCELLATIONS AND REFUNDS

Notification of cancellation must be made in writing, with the cancellation date being the postal service postmark date. At the time we receive your notification, the following charges apply: (charges are per person)

Up to 90 days before departure	10% of tour price
89 - 30 days before departure:	30% of tour price
29 - 0 days before departure	100% of tour price

Commercial trip cancellation insurance is available from many sources and is recommended. Refunds for services that are voluntarily not used will not be made.

TOUR RATES
